

Greg,

I will pass along the information that I have with the golf cart path repair so hopefully you can proceed or find a company that is reasonable. I have not been successful with three companies one of which lifts concrete with polyurethane (Precision Concrete Leveling) and another that stabilizes soils with the injection of Uretek (Concrete Stabilization Technologies). These are companies that I have had in the area for other repairs and they both looked at the patch that needs to be repaired, and suggested to remove and replace. I understand that the ultimate fix is to remove and replace, however the cost is substantial so I explained to them that we would like by some time with a temporary patch repair. I contacted a Committee member by the name of Craig Clement and scheduled a time to meet him at the golf course on Monday April 7, 2014. He suggested that he could arrange a young men's project and inject a grout into the slab to fill the voids under the concrete and finish the surface to match the existing. This meeting on site did not happen and I

have left numerous messages since. The City will cover the cost of the material. Quicksilver has not sent us a quote to repair it, but they will be working on Sugarloaf this week:


