<u>Item 8-Review/Action on an Ordinance Amending Title 1, Chapter 5, Relating to Non-flash Still Photography and Video Recording of Public Meetings</u>

Mayor Gygi stated that in speaking to Sergeant Liddiard, he has learned that some of the language needs to be changed in this ordinance. Anyone with a video camera has a right to be wherever they want to be, and those that come to a public meeting have no privacy guarantee. The language about removing someone that moves their camera during the meeting needs to be stricken from the ordinance.

C. Zappala suggested putting language in that addresses specific concerns, such as not blocking others, and keeping the aisles open and clear.

Sergeant Liddiard stated that for the security of council, no one should be allowed behind the council table. The prosecutor's office will not prosecute anyone for being disruptive because of location of camera location.
